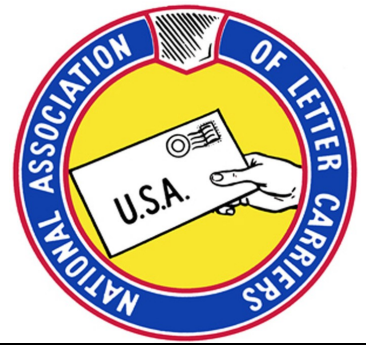

125 YEARS OLD
MOVING ONWARD AND UPWARD

For those who have gone before and those of us who are here now. The Branch 111 of the National Association of Letter Carriers of Salt Lake City, Utah is now in our 125th year as a union organization which began on Jan. 5, 1891. We were a 100 years old on Jan. 5, 1992. We produced a 100th yearbook then and now a 125th year book (There is no year book). Maybe those of the future will make a 150th yearbook.

We have had many changes in the last 25 years. Changes in the workings of the United States Post Office and its operating procedures and the way letter carriers do their work. The National Leaders and our local Branch Leaders always tried their best to get the best results for carriers from theses many changes.

In 1991, a process which was started in 1984 called Employee Involvement (a program with union and management representation) which was on a National level and also in many work locations. It was to help resolve work related issues and atmosphere, and attitude. In 1991 our local branch had a few months discussion to withdraw from this process. As time went on the post office and the union had problems with each on the automation processing of the mail and after 14 years of the Employee Involvement the Post Office unilaterally withdrew from E.I.

In 1992 the Post Office offered an Early Out for postal employees. It was mainly to reduce the number of management personnel, but was also offered to all crafts. Post office was later surprised to see that many craft took it than management. 25 people in our branch opted to retire. Joe Wood our first full time president was one of them. One early out was offered another time but the offering was not good enough to want to opt for it. Some may have taken it.

We had many meetings as an executive board and at monthly union meetings to discuss if we should have a full-time president. There were inquiries to other branches who had full-time presidents. There was discussion about pay, benefits and etc. But in the year 1993, we voted to have a full-time president. We have had a fulltime president since then, and up to this year 2017, and continuing. They are elected for 3 year terms.

In the late 1980's and maybe 1990 automation of mail was beginning, with the use of barcodes. First process was called sector segmented mail. A part of a row on a mail case would be cased in. The old way was to look at each letter and put it where its address is on the case. As the barcode system improved with machine technology, the next process was called Delivery Point Sequence mail (DPS). Sector segmented and DPS mail was tested at Custer annex office which was only about 2 miles from the main processing plant.

Therefore it was tested there with the carriers. Much discussion was going on nationally and locally on how to implement this process without harming the carriers' jobs and union rights and our way of life. These types of issues are still going on today because of technological changes taking place. DPS took about 3 years before it was to go online in Branch 111 offices. A few offices at a time, DPS is still in usage as of today, 2017. Many times management tried to use this process against us, the union, in discipline, inspections, etc.

In 1997 the Branch decided to change the Branch name. We were called, "Center of Scenic America". We changed it to the "Wasatch Branch", because of the Wasatch Mountains of the Salt Lake Valley. The branch was able to be online by having the internet and establish our e-mail address. We had so many things going on that the union changed the Presidents' 30 days to 90 days in 1998.

In the next 2 years, 1999 through 2001, many national incidents in the postal world happened. There was an anthrax scare in 1999. In the year 2001, 2 New York postal employees die from anthrax. In 2000, leave time management and DOIS moved forward. There was also a co-leader route inspection process. During this contract there was an upgrade from Level 5 to Level 6. Legislatively, 2 bills were in congress to try to change the Windfall and Pension Offset of Social Security.

In 2002, Salt Lake City was host to the 2002 Winter Olympics, which gave our carriers an opportunity to help. A bomb scare during the Olympics. A package found by a carrier. He was told to bring it back the Post Office. Ed Mayne, AFL-CIO President and State Senator brought to our union meeting the Olympic Torch. He carried it and all present at the meeting got to hold it. Our Branch union membership was 83% organized in 2000. Due to route inspections, which have been going for more than 40 years, 3 zones were awarded \$50,000 in inspection violations.

We have been in our current union office for many years. We've grown in membership and over the years costs for building maintenance went up, etc. We had talks of buying our own building. But, we were able to purchase the adjacent space to our office. In 2003, we did so. We paid for

remodeling and bought new furniture for our office space adjustments. We allow others in the building to use the extra room for some of their meetings.

It was only a year after the Olympics and a year or two before that about the anthrax situation, that year, 2003, a letter with white powder showed up at the IRS in Utah. It was determined that, after being tested, it only had trace amounts of radioactivity. But yet, still in 2004, a package was outside of the front doors of the Sugarhouse Post Office. The building was evacuated. Package was tested. It was a package full of clothes and personal items, they think of a homeless person.

For many years the Postal Inspectors (P.I.) had overseen all criminal and other serious postal rules violations. But in and around 2005 a part of the government known as Office of Inspector General, took over a whole lot of the P.I. responsibilities and so many more areas. They showed their presence pretty heavy here and everywhere.

Our National Union has had and does have ways to help carriers for their preparation during and after they retire. They also have helped family's children by having a scholarship program. Daughter of our sister carrier, Cassandra Last was the first one in our Branch to receive a scholarship. The scholarship

The Post Office lost a lot of parcel delivery way back in the 70's. But with carriers using a program called "Customer Connect" and later contracts with other companies, delivering of packages has increased. We now are called the last mile delivery of packages and are delivering packages for UPS and FedEx when they bring them to us. Postal Reform has happened a few times over the years. 1970 was a very important one at that time. But, as time goes on technology changes and some reform comes up again. Another reform passed again in 2006. It had been discussed over and over the years before it passed.

Many employees when hired usually sign up for life insurance. Unlike health insurance, which is offered to the employee to change every year if they want to. Life insurance has had only two open seasons in the last 40 years.

In the year, 2011, there were many carrier rallies, visits to congressmen, carriers going to town meetings; there were some new bills that were somewhat favorable for us to maintain our service to the American people. COLCPE is a program to donate funds to help get our government to listen to us, lobbying. We had 37 new union members join up in our branch in 2011.

There was, in one of the years that if people could get so many signatures on a petition for a desired item or change, the government would listen to it or bring it before congress or put the item on a ballot. A million signatures were on a petition in 2012 to save the Post Office. Other changes were happening in 2012. 700,000 employees were employed in the Post Office in year 2000, in 2012 down to 491,000. Post Office wanted to reduce it 66,000 more to make it less. Things seem to go around in circles. We still had to fight to save the Post Office even in 2012. We had local rallies in Salt Lake. We had a new contract all agreed upon, but the Postmaster General wouldn't sign it, so it went to arbitration. A House Bill (HR2309) was presented this year of 2012 and it was not a good bill.

Not sure if it is a first in our local Branch or a first on a National level, but in 2014, a carrier in our Downtown Postal facility was bitten by a raccoon. The raccoon was caught a few weeks later. Carrier needed rabies shots.

Carriers helped to build the Post Office parcel situation. A program called Customer Connect was started many years earlier. In 2012, it was told since inception of the program, that 2 billion dollars have been generated.

There are years of ups and downs, if not every year. 2012 saw maybe the largest COLA increase, \$1227.00. The down was a cyber breach of the Government of thousands of Federal employees. This compromised names, addresses & social security numbers.

One great up for our branch was the first woman carrier in Salt Lake City. It was Barrie Frankland, now retired. We now have a woman Postmaster General, Megan Brennan.

Sometimes abbreviations change for more direct meaning or clarity. The COLCPE abbreviation was changed to LCPF (LETTER CARRIER POLITICAL FUND).

2016 is the 25th year after our 100th year anniversary. The year 2016 saw a few interesting things happen. FEGLI had its 3rd Open season in the last 30+ years. Most of all for our Branch, and many of our Branch leaders established legislation with Utah Congress and also presented it to our Utah Congressional Representatives to the United States Congress. We as a state are able now to be an important resource to the State as 1st Responders in a declared emergency. Also, the state can use the Post Office for other uses such as Passports, etc.

Pension offset & Windfall Elimination; Just prior to Olympics a potential bomb next to a collection box; Ed Mayne our AFL-CIO President & UT State Senator presented the Olympic Torch that he carried during the Olympics; All present got to hold it.

2012

1 million signatures on petition to save the Post Office. Casers, streeters, loaders. 700,000 employees in year 2000; 2012 only 491,000 employees; PO wants to reduce 66,000 employees more. Rally at Salt Lake Federal Bldg. 3 TV stations present.

Contract agreed upon but Postmaster would-n't sign it – it went to Arbitration.

2014

Downtown carrier bit by a raccoon. Large COLA – maybe largest ever to date, \$1227.00. Customer Connect generated 2 billion since inception. Federal Govt. cyber breach affects employees' names, addresses, & Social Security #'s. Megan Brennan, 1st woman Postmaster General.

2015

COLCPE is now LCPF (Letter Carrier Political Fund).

2016

Utah legislation to use USPS as a resource to 1st Responders in a declared emergency. Union endorses Hilary Clinton for President of the United States. Branch 111's Auxiliary 8 disbanded. FEGLI open season Oct 2016.
