

#### **The President's Report**

### American Rescue Plan Act & The Ratified Contract

It has been a busy four weeks since my last Article: The contract is ratified and the American Rescue Plan is now the law! Over 94% of participating eligible members voted to accept the contract with the final tally being: 60,111 for, and 3,341 against. More than that combined total declined to vote, which is a sad statement considering how easy it was to do so. The date of ratification was 3-8-21.

I gave the highlights of the new contract in a previous article, but I need to go over the most relevant timelines in this article. The Post Office will do pay adjustments for back-pay "as soon as practicable" (including back-pay for people who retired since 11-23-19). I would guess, based on the implementation of the last contract, that this will occur some-time this Summer. The new step (Step P) will come into being on 11-19-22. CCAs with 24 months of service will be automatically converted to PTF status within 60 days of ratification. The ability to earn Annual Leave in lieu of Holiday Pay will start with the holiday occurring 7-4-21. Starting no later than 60 days from ratification, MSP Scans will no longer be used. Local Memorandum Of Understanding negotiations will begin 4-29-21 and will be completed on 5-28-21. Yesterday, President Biden signed the "American Rescue Plan Act" into law. According to CBS:

"The American Rescue Plan provides \$1,400 direct payments to individuals making up to \$75,000 annually, \$350 billion in aid to state and local governments and \$14 billion for vaccine distribution. The bill also provides \$130 billion to elementary, middle and high schools to assist with safe reopening."

In addition to this, the Act also grants much needed leave to Letter Carriers who have to take time off work for COVID-19 related issues. If you remember, The Coronavirus Aid, Relief, and Economic Security (CARES) Act expired 12-31-20, so Letter Carriers have had a hard time obtaining COVID-19 related leave for the last 2-1/2 months. According to NALC.org, the "American Rescue Plan Act" (ARPA):

"provides up to 600 hours of paid leave for each full-time employee or a proportional equivalent for part-time employees at a capped rate of \$35 per hour and no more than \$1,400 per week. The bill also carries forward the same COVID-related reasons for using the leave that were included in the FFCRA but adds new reasons, such as getting vaccinated. While the FFCRA required leave be paid at only 2/3 rate for certain reasons, this bill contains no such reduction in the rate the leave is paid. A \$570 million fund is included to pay for the leave.

Workers' compensation language that presumes a positive COVID-19 diagnosis for postal (and federal) employees as work-related. The presumption would authorize benefits such as medical, disability and survivor benefits for workers who contracted COVID-19 in the three-year period beginning January 27, 2020 and ending January 27, 2023.

While all of this seems fantastic, our experience with the USPS during the last 12 months in dealing with anything COVID-19 related has taught us that USPS policy will change many times while their lawyers and experts figure out exactly how to implement the provisions of the American Rescue Plan Act. After the CARES Act was signed into law, it seemed that USPS policy changed weekly, and the NALC developed an alternative dispute resolution process at the national level to deal with individual situations on a case -by-case basis. I am sure that in the coming weeks we will see similar "scrambling" as the USPS tries to figure out how they will deal with this new law.

The best advice that I can give is: If you have symptoms of COVID-19 don't come to work and go and get tested. If you have been quarantined by a doctor, or by a State Official, stay at home while quarantined. If your child is out of school due to a COVID-19 related closing and you need to take care of them, do so. The NALC will get the everchanging information about the "American Rescue Plan Act" dispersed as quickly as we can, including how the USPS is dealing with it, but please be patient as things can change quickly.

I received my first dose of the COVID-19 vaccine a couple of days ago (based on age qualification in the State of Utah), and I can say that for me the process was quick and nearly painless. To get information about getting the vaccination, go to www.coronavirus.utah.gov.

Thanks again for serving our community as "Front-Line Essential Workers"! (Even if the Governor still does not acknowledge us as such.)

• Changes are coming to ECOMP by August. It will be more user friendly (web based). Users will be able to go online and see all of their information related to their compensation case. Now you can only see the forms. They are trying to get everyone to register with OWCP on ECOMP. If something happens you can quickly get on your phone, tablet, or a computer and file a CA-1 (report of injury). You can also use a computer at work. This will get around management submitting (or not) your claim through Human Resources. Bob advises all active carrier to get registered on ECOMP (www.ecomp.dol.gov).

#### **EXECUTIVE VICE PRESIDENT** by Mike Hansen

•Grievance report: 550 filed so far this year. •Case filing is all caught up.

•Those 50 and older, BMIs over 30, diabetes and some other conditions can now get vaccinated. By April or May, everyone should be able to get their shots.

Pres. Biden signed the new Covid Rescue bill, similar to Family First, for federal workers who need to use leave for Covid related issues (childcare, school closing, covid, etc). •Another bill was signed for \$570 million allocated for federal workers to use for Covid related problems, including 600 hours of leave. There is also vaccine leave to get vaccinated or for complications with vaccinations. Goes until Sept 30<sup>th</sup>. There is no more 2/3 limitation as in Family First. The plan can be used for virtual learning for your kids. See nalc.org for more info.

#### PRESIDENT by Mike Wahlquist

•New Covid Stimulus Plan (posted on nalc.org): It establishes a federal emergency leave fund, for federal and postal employees, replacing the 2020 Family First (FFCA) program that expired December 31<sup>st</sup>. It provides up to 600 hours of paid leave for each full-time employee with a proportional amount to part time workers. Same covid related reasons as in the FFCA but includes getting vaccinated. This bill has no 2/3 reduction like the previous bill. Workers Compensation language presumes a positive Covid-19 diagnosis for employees as work related. Benefits include

medical, disability, and survivor benefits for workers who contract Covid for a 3-year period beginning January 27, 2020. This is very good news !!

•The Executive Board anticipates having a physical branch meeting in May. •Zoom meeting in April. •Planning a June summer party, a steak fry in August, and a retiree party in late fall. •Covid report: cases are way down in our branch. There was trouble at Sandy main office, otherwise there was only a couple others in the last two weeks.

#### **SPECIAL ORDERS:**

• Executive board approved a motion to spend up to \$15,000 to renovate the branch office (flooring, paint, etc). It has been at least 25 years since there has been any work done on the office. Motion passed (25 for and 5 against).

#### GOOD OF THE ASSOCIATION:

• Next year the Grace Carroll Rocky Mountain Labor School will be held in Utah the week of July 14<sup>th</sup>. We don't know who will be moving or where.
