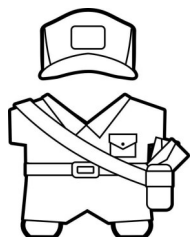
**While we normally work extra hours during peak season, this year will be more challenging than any we have faced. This is almost entirely caused by our staffing shortage. I wish I could tell you that our staffing problems would (or even could) be fixed in the near future, but as you all know, that will not be the case. Just remember that if you become too fatigued to continue on any given day, you should let your Supervisor know and go home. Your safety and health always come first.**

**I started with the Post Office back in 1987, and I have had the opportunity to carry mail through quite a few peak seasons. I think that one of the worst days I ever had working for the Post Office was on Christmas Eve in 1987. My manager had me out delivering mail for about 14 hours that day. Near the end of the night, when I was weary and irritable, I accidentally drove past a house that I couldn't see in the dark, and I missed a parcel delivery. Upset that I had missed the parcel and that I would now have to spend extra time back-tracking, I slammed my quarter-ton Jeep into reverse and started driving backwards in the direction of the missed delivery, hearing the engine whine as I accelerated. I suddenly came to my senses and thought, "What am I doing driving in reverse for all this distance?", and I hit my brakes... just in time to avoid hitting a parked truck which I could now see in my Jeep's rear window (which in those tiny Jeeps was about 5 feet from my face). I literally could see the bumper of the truck just inches away from the glass. I breathed a huge sigh of relief when I realized that in my haste and fatigue (and terrible judgement), I just about had an accident that would have made that night and the next day (Christmas) absolutely miserable, for myself, my family, the patrons on my route, not to mention my Supervisor and Station Manager who would have had to leave their Christmas Eve parties to come out and photograph the scene (of course since I was out that late, having them leave their warm houses to come out to my route might have made me a**

little happier). I learned a valuable lesson that night, which was to stay calm while delivering and to not sacrifice safety for anything.

I have had many years to think about how Letter Carriers are a lot like Santa Claus. We both deliver presents. We both deliver on Christmas Eve. We both get a lot of cookies from our customers. We both know which of our customers are naughty or nice (in fact I think we probably know a bit more than Santa on that score). And we both get the blame when something doesn't show up. I hope that we can all remember to stay safe and remain calm during this peak holiday season. If you are struggling to do so, please do not hesitate to call me.

I haven't received as of the writing of this article, my health booklets from the health plan for 2023 coverage. I'm not sure of what's in it yet. What they have sent me is an over-view booklet for all the options of the plan that we've had the last few years. What's really good is since the years from 2020 to 2022 the only change is that all the co-payments went from \$20.00 to \$25.00. As far as I can tell everything else stayed the same.

I'm going to hold an informational class on December 1<sup>st</sup> and December 8<sup>th</sup> at 5:30 pm at the union hall. It will be about the new NALC High Option Plan-Aetna Medicare Advantage. This will give all who are on Medicare more understanding about it.

Currently, the first information received about this new plan, a person wanting to opt-in this new plan has till December 13<sup>th</sup> 2022. But it is also written if you want to opt-in after December 13<sup>th</sup> you should do it as soon as possible. No matter which way it takes effect January 1<sup>st</sup> 2023.

If anyone during open season doesn't want to do any changes they will continue what they have and it will just continue through out 2023.

**LEGISLATIVE** by Chad Mortensen

- Branch 111 is being recognized politically as an entity that people want to help us and get our support. The USPS is the most trusted federal agency.
- Last week was the Utah Legislative Gun Shoot. The NALC was represented by Dee Frankland (president of a Washington state branch) who came to represent our union (because rap session was at the same time). She had never shot a gun before, but came to learn more about what is going on legislatively. She, Rep. Jim Dunnigan, Rep. Handy, and Chad took third place. Next year we will try to have more teams.

- **This year a bill is being introduced in Utah that will prohibit companies from deducting union dues automatically from employees pay checks.** This is union busting legislation that we will have to fight this year.

#### **MBA, COMPENSATION** by Bob Jewell

- Thanks to members in our branch who are helping injured carriers get their compensation forms filed properly rather than leaving it to management to do (many errors and omissions). If you don't complete your forms on line a manager will do it for you using your paper forms. In one case Bob helped fix errors where a manager turned in a paper CA-1 form and the staff who entered the form digitally got the name backwards and the date of injury wrong.
- It is very important for every carrier to get registered with OWCP so they can quickly record an injury (even while still on the route) and get medical treatment immediately.
- It is winter, be careful.

#### **HEALTH BENEFITS** by Jim Kerekes

- Open season start Monday and ends Dec. 12<sup>th</sup>. Any changes have to be turned in before 10pm on the 12<sup>th</sup>.
- For those on Medicare: Medicare part D is the government prescription plan. If you have Medicare and Part B, getting part D is double coverage and not needed.
- For next year, NALC is offering a High Option Plan for annuitants - Aetna Medicare Advantage. You would still have to pay your NALC premiums. No additional charges for Aetna. Plus, there is a \$75 reduction, per person, each month for Part B premiums. It has unlimited physical, occupational, and speech therapy visits. Dental and vision needs more research. In the Aetna plan the medicine costs are about the same as NALC HB.
