Grievances are over 1,500 so far this year which is close to average. •NALC has a regular podcast called *You Are The Current Resident* which has COVID updates and other topics important to letter carriers (youarethecurrentresident.podbean.com). You can get the podcast on Apple or Podbean. •We are in need of your unused uniforms for new CCAs. You can bring them to the office or call and we will pick them up. •There is a tentative agreement on the national contract. There are 4 annual wage increases and 7 COLAs, some being retroactive. CCAs will get an additional 1% increase at each wage increase. CCAs will be converted to career status after 24 months. They will get another step increase. Information on the tentative agreement will be in the Postal Record and the NALC Bulletin (see at nalc.org). •Stewards need to be diligent in seeing that there are regular Covid standups in your offices. •Covid: If you have an issue with using up your covid leave, call the union office before you just accept that you are out of your Family First medical leave or other leave. There may be other options. Many emergency agreements will be expiring on the 31<sup>st</sup> but are expected to be extended.
